MAKING A "FUNDAMENTAL CHANGE IN THE GLOBAL EQUATION ON MIGRATION": THE RWANDA BILL AND MEDIA STORYTELLING

Abstract

After the media frenzy over Brexit abated, media reporting in the UK concerning the topic of immigration continued to hit the headlines. A subject that led to intensive media coverage was, in 2023 and 2024, the so-called "Rwanda Bill", under Conservative Prime Minister Rishi Sunak. The solution of sending asylum seekers to Africa received public criticism, despite the Prime Minister's statement in April 2024, according to which the bill was meant to make "a fundamental change in the global equation on migration" (BBC News).

The article discusses such concepts as narrative journalism and media storytelling, which involve the use of literary techniques in their transmission of information, as well as their relation to the concept of hyper-narratology. In its applicative part, it aims to identify and analyse a range of media stories surrounding the Rwanda scheme in the months preceding the general election of 2024 in the UK, sourced from English and Romanian online news providers. The comparative analysis starts from the premise that the discursive strategies at work in the Romanian and English media differ on multiple levels.

CLIMATE CHANGE IN KORÇA REGION: CHALLENGES AND OPPORTUNITIES FOR A SUSTAINABLE FUTURE FOR AGRICULTURAL PRODUCTION

Abstract

Agriculture is the main economic sector of Korça Region. It contributes 43.2% to the regional economy's GDP and is the main source of employment. Climate change is a significant threat to agriculture, reducing crop yields, thermal and water soil quality, water resources, and regional food security. This study holistically analyzes climate change in the Korça region and its impact on agricultural crops, highlighting the urgent need for innovation and adaptation. Significant changes were identified in agroclimatic indicators such as changes in temperature, precipitation patterns, extreme weather events, and changes in the dynamics of pests and diseases. These changes have profound implications for agricultural production, the rural economy, and the sustainability of ecosystems. Climate change presents a challenge for finding better ways including crop diversification, water management, application of new agricultural practices, technological innovation, and eco-compatible agriculture. They are essential for increasing the resilience of agricultural systems to climate change. Data collected from hydrometeorological stations in the Korça region, Albania, were processed and compared with the corresponding data indicators from the previous 30-year periods. The increase in temperature represents a trend without significant fluctuations from one year to the next. The annual amount of precipitation does not show any significant changes, while a greater concern is the amount of rain falling on fewer days but in larger quantities, affecting the increase in the drought period. Changes in agroclimatic indicators present a challenge for producers in the field of agriculture, for remodeling agricultural areas and determining the most appropriate technologies for cultivating agricultural crops.

Abstract

Wine aging involves a series of complex physical and chemical transformations, including micro-oxygenation and the development of volatile and non-volatile compounds, which enhance the sensory complexity and overall quality of wine. The choice of aging vessel, ranging from stainless steel tanks and cement vats to oak barrels and clay amphorae, plays a critical role in shaping wine attributes. While stainless steel and cement vessels exert minimal influence on sensory properties, wood and clay vessels often impart distinctive aromas and flavours through the release of compounds such as vanillin, lactones, furanic derivatives, and phenolic volatiles.

This study aims to investigate the winemaking and aging processes of wines matured in different vessel types, with a focus on understanding how aging materials influence the chemical, microbial, and sensory characteristics. Chemical analyses, including the quantification of phenolic compounds, tannins, and volatile components, will be performed using High-Performance Liquid Chromatography (HPLC). Microbial analyses will assess the activity and dynamics of wine-associated microbiota under varying aging conditions, while spectrophotometric colour stability tests will monitor changes in visual quality over time.

The resulting data will be statistically evaluated to identify significant correlations between vessel type, wine composition, and sensory quality. The findings of this project are expected to provide valuable insights for both academic research and the wine industry, ultimately supporting the development of evidence-based best practices for wine aging.

ORGANIC DESIGN AND SYNTHESIS OF HIERARCHICALLY POROUS POLYHIPES POLYMERS THROUGH EMULSION TEMPLATING AND HYPERCROSSLINKING

Abstract

Porous polymers with precisely controlled architectures are increasingly important in organic chemistry due to their versatile applications in catalysis, adsorption, and selective separation. In this study, hierarchically porous PolyHIPE-type polymers were prepared using emulsion templating followed by hypercrosslinking. The emulsion templating method generates interconnected macropores, while hypercrosslinking introduces meso-and microporosity, significantly enhancing specific surface area and mass transport properties. This dual approach produces mechanically robust materials with high structural integrity, making them suitable for catalytic systems, separation, adsorption, solid supports in organic synthesis etc. The results highlight that careful control of porosity and intermolecular crosslinking is essential for designing high-performance functional organic polymers.

The increasing generation and improper management of hazardous waste in Albania pose significant threats to the marine ecosystem, particularly along the Adriatic and Ionian coastlines. This study aims to assess the current risks associated with hazardous waste disposal and propose effective safety management strategies to mitigate environmental damage. Through a combination of risk assessment models, field data, and policy analysis, the research identifies key sources of hazardous waste, evaluates their impact on marine biodiversity, and highlights weaknesses in existing safety protocols. The findings emphasize the urgent need for preventive measures, investment in waste treatment infrastructure, and strict enforcement of environmental regulations to ensure the sustainable preservation of Albania's marine environment.

This study investigates the sources, risks, and safety management practices related to hazardous waste affecting the Albanian marine ecosystem. Industrial discharges, untreated urban sewage, agricultural runoff, medical waste, and maritime activities contribute significantly to marine pollution and ecosystem degradation. A comprehensive risk analysis reveals high levels of environmental threats, including bioaccumulation, eutrophication, and direct human health impacts through seafood contamination and recreational exposure. The current waste management system in Albania is characterized by weak infrastructure, fragmented institutional oversight, and limited public engagement. To address these challenges, this paper proposes sustainable, integrated strategies focused on strengthening legal frameworks, improving hazardous waste treatment infrastructure, enhancing marine monitoring, and fostering community awareness. The adoption of these measures is essential to safeguarding the Albanian marine environment and ensuring sustainable coastal development.

Abstract

In recent years, the inclusion of STEM (Science, Technology, Engineering and Mathematics) in education has increasingly taken on an important place in the pre-university education curriculum in Albania. This encourages a contemporary educational reform that aims to promote interdisciplinary learning. In this regard, it is necessary to adapt the concepts of each discipline, including mathematics, to the requirements and principles of this innovation in education.

Our study highlights the views of mathematics teachers in the Korça region on integrating mathematical concepts into STEM and the benefits of this approach in teaching.

We conducted our research in two phases. In the first phase, a questionnaire was conducted with mathematics teachers in the Korça region, with the aim of assessing their knowledge of STEM. In the second phase, an experiment was conducted with two ninth-grade classes, where in one class STEM was used to address the concept of function, while in the other the teaching was carried out in accordance with the currently implemented curriculum.

The results of the study show that the premises are very good for the efficiency that the use of STEM has in assimilating mathematical concepts, especially in the practical and interdisciplinary aspect. Also, teachers are willing to integrate STEM into education if the necessary conditions for its effective implementation are met.

Based on the novel's central themes of institutional control and lack of free will, the study examines how language expresses the

By foregrounding concealment of linguistically expressed agency, the paper aims to contribute to broader discussions in translation studies, discourse analysis, and the language of emotion in fiction.

CHALLENGES AT WORK AND PROFESSIONAL BURNOUT AMONG PRIMARY TEACHERS: THE KOSOVO CASE STUDY

Abstract

This study investigates the relationship between work-related stressors and professional burnout among primary school teachers in Kosovo. Teachers often face numerous challenges and pressures associated with their daily duties, which can significantly affect their level of professional burnout. The main purpose of this research is to examine how work-related stressors influence burnout and to identify factors that may help mitigate its effects. A quantitative research methodology was employed, involving 500 participants from 10 primary schools in Kosovo. The sample was selected randomly to ensure a representative distribution. The findings reveal a significant positive correlation between work-related stressors and professional burnout among teachers (Spearman's rho = 0.670, p < 0.05). This indicates that higher levels of job stressors are associated with increased burnout. Further analysis shows that work experience and professional training have a substantial impact on reducing burnout levels (R Square = 0.721, p < 0.001). No statistically significant differences were found between male and female teachers regarding stress levels and burnout.

These results highlight the importance of improving working conditions and providing adequate professional development programs to reduce teacher burnout. The study offers valuable insights for policymakers and school administrators in Kosovo to develop strategies that can alleviate stress and improve the overall working environment for teachers.

STABILITY OF MENTAL HEALTH SYMPTOMS AMONG UNIVERSITY STUDENTS AND EARLY- CAREER EDUCATORS: EVIDENCE FROM A THREE-WAVE LONGITUDINAL STUDY

Abstract

This longitudinal study examined trajectories of anxiety and depression symptoms among students from the preschool education department during and after the COVID-19 pandemic, and again in 2025. Data were collected in three waves: June 2021 (n = 312), September 2023 (n = 217), and September 2025 (n = 166, now employed as educators). Depression and anxiety symptoms were measured using the PHQ-9 and GAD-7 scales. Logistic regression models (GLM in R) with year of study and socioeconomic status (SES) as predictors estimated adjusted odds ratios (AORs) for symptom recovery or onset across waves.

Results indicated small changes in the prevalence of depression, but anxiety levels varied more substantially and reached statistical significance (p < .05). Graduate students and those with lower SES reported higher anxiety scores. Contrary to expectations of post-pandemic recovery, the overall trajectory reflected symptom stability over time.

This persistence may be linked to insufficient mental health support within university systems and broader healthcare services. The findings highlight the need for comprehensive and accessible mental health strategies in higher education to promote early detection, prevention, and long-term support for students and educators.

The metallurgical sector and energy generation are currently in crisis, hindered by outdated industrial practices, environmental pollution, inefficient raw material use, and insecure energy supply. These factors obstruct Kosovo's integration into the EU single market and deepen longterm developmental constraints. Recent global energy developments, especially after the Ukraine conflict, have shifted debates from COP21 and COP26 commitments toward compromise policies at COP28, emphasizing the gradual phase-out of fossil fuels and the deployment of CO₂-reducing technologies. Within this framework, the EU has reclassified gas and nuclear energy as transitional "clean" sources and is supporting reforms in the Western Balkans to encourage innovative approaches in mineral resource exploitation. Abstract

The health of the financial sector and banking stability presents highly controversial issues today. This paper analyses and compares Non-performing Loans (NPLs) in Six Western Balkans Countries (WB6): Albania, Bosnia and Herzegovina, Kosovo, Macedonia, Montenegro, and Serbia as a critical indicator of the health of the financial sector and banking stability in this region. The average of the NPL for the WB6, for the period 2008-2015 was 12.96%, with highest rate in Serbia from 18.40%, and the lowest rate in Kosovo with 6.25%. Results for the last decade in WB6 has fallen shortly from double-digit levels to single-digit level. Along with the period 2008-2015, Kosovo also had the lowest NPL rate in the last decade, which represents a good performance. The main roots of this are the extremely conservative policies of the banks that do business in the Kosovo market as well as the high nominal value of the pledged collateral, which is typically greater than twice the amount of the applied loans.

THE IMPACT OF REMITTANCES ON ALBANIA'S ECONOMIC GROWTH

Abstract

This study examines the impact of remittances on Albania's economic growth. Beginning with the recognition of emigration as an inseparable socioeconomic reality since the 1990s, the paper explores the role of remittances as both a vital source of income for households and a key macroeconomic factor. The study employs a mixed-methods approach: on one hand, a theoretical analysis of existing literature identifying the mechanisms through which remittances influence consumption, investment, savings, and economic stability; on the other, the construction of an econometric model to test the relationship between remittances and Gross Domestic Product (GDP) for the period 1992–2023. The findings reveal a strong, positive, and statistically significant relationship between remittances and GDP growth, confirming their substantial contribution to the country's economic development. However, the study emphasizes that this impact is not uniform. When remittances are used primarily for short-term consumption needs, their effect on long-term development remains limited. Conversely, when channeled toward productive investments, education, and entrepreneurial initiatives, they can become a powerful tool for sustainable development. In this context, particular attention is given to the role of public policies in directing remittances toward sectors with high economic and social impact. The study is based on the development of an econometric model implemented using the E-Views software.

DETERMINING THE MINIMUM OPTIMAL SAMPLE SIZE FOR EXPLORATORY STRUCTURAL EQUATION MODELING: A MONTE CARLO SIMULATION STUDY

Researchers often, when they have at their disposal a psychometrically sound measurement instrument, resulting from a previous study, which they intend to use in other studies, need to

make an evaluation of the sample size, regarding the number of individuals to be included in the study. It may be that the measurement instrument continues to maintain its unbiasedness, or exhibits non-significant bias, even for a smaller sample size than that used in the original study. This could help researchers save costs, time, or address other potential difficulties that can commonly occur during data collection. For the study of phenomena that require the use of complex models such as Structural Equation Modeling, researchers in determining sample size should not focus only on specific guidelines regarding anticipated effect size or desired statistical power level, but should examine the phenomenon in a more holistic way. This study, based on Monte Carlo simulations, testing different sample sizes systematically, aims to determine the minimum sample size required to achieve reliable model estimates of factor loadings, standard errors, factor correlations, residual variances, in addition to statistical predictive power, assessing how these indicators behave under various conditions. These simulations, for population parameter values, for data generation and coverage, used parameter estimates saved from a real data analysis with 603 students of the University of Korça, assessing their digital skills through Exploratory Structural Equation Modeling. The model showed satisfactory unbiasedness even for smaller sample sizes.

The Independence Day, also known as Flag Day, began to be officially celebrated in Albania following November 28, 1912. Gradually, this day evolved into a symbolic occasion, serving as a collective national celebration for all Albanians. Immediately after the declaration of independence, the city of Korça was occupied, and for an extended period, the territorial status of the region remained unresolved. The decision rendered on March 22, 1913, by the London Conference of Ambassadors established Korca as part of Albania. Thucydides analyzes memory as a human, personal, and fallible faculty, but at the same time sees it as necessary for constructing the past.

In this context, memory is presented as a necessity for narrating the facts that come to us from the past; as a result of recollection, what is called the "machinery of memory" is born. Research shows that studies on memory date back to the early decades of the 20th century, primarily the

1920s, when the term "collective memory" first appears. Scholars such as Aby Warburg, Maurice Halbwachs, Marc Bloch, Jacques Le Goff, Pierre Nora, and others have made very important contributions through their studies. Essentially, memory produces its own derivatives, such as "collective memory," "cultural memory," "public memory," "collective commemorations," or "communities of memory." Equally important are the producers of memory — those who recount the past as contemporaries of a given historical period — and the consumers of memory, those who choose to refer to collective memory in various ways. Consumers may choose to be skeptical, to believe, or to transform memory; however, without historical documentation, a narrative based on memory would remain only a "legend."

The archive remains a very important institution tasked with processing, managing, preserving, and providing documentation, playing a primary role in transmitting the past. Abstract

This paper examines the socioeconomic factors driving potential migration from southeastern Albania, with a specific focus on the Korça region, and analyses its implications for future regional development. The study is based on a structured survey conducted with 486 participants across urban and rural areas of the region. It explores both internal (within Albania) and international migration intentions, emphasising the factors that influence individuals' decisions to consider leaving their homes. The aim is to identify key push factors behind migration intentions and analyse the expected economic, social, and cultural impacts of migration flows on future development.

The study revealed that the main reasons for potential migration from the Korça region include limited employment opportunities, dissatisfaction with public services, the quality of education and healthcare, and family reunification. Findings indicate that potential migration is particularly high among young people and skilled individuals, raising concerns about future demographic imbalances and the erosion of human capital. These dynamics pose significant challenges to sustainable development in the region, including the labour market, reduced local economic activity, and increased dependence on remittances. The study emphasises the need for comprehensive regional development strategies that address structural socioeconomic inequalities, improve local livelihoods, and create conditions that encourage people—especially the youth—to stay and invest in their communities.

FACTORS INFLUENCING NON-PERFORMING LOANS

Abstract

The Albanian banking system represents the most important sector of the Albanian financial system. Over the past few years, the banking sector has faced numerous challenges, including significant transformations resulting from technological advancements and fluctuations in the level of non-performing loans. Naturally, factors such as the COVID-19 pandemic, the Russia–Ukraine war, as well as various macroeconomic and microeconomic conditions, have had an impact. Macroeconomic and microeconomic factors play a crucial role in determining the level of non-performing loans. This paper focuses on the impact of several macroeconomic factors—such as interest rates, exchange rates, inflation rates, unemployment, and financial crises—on the level of non-performing loans.

The level of non-performing loans affects banking efficiency, which in turn influences financial stability and the real economy. An increasing ratio of non-performing loans indicates a vulnerable financial system, whereas a lower ratio reflects a healthy and stable one. Furthermore, non-performing loans reduce banks' profitability, which translates into a contraction of credit supply to businesses and individuals in the real economy. For this study, secondary data were obtained from the Bank of Albania and INSTAT, while primary data were collected through a questionnaire conducted with borrowers. The findings indicate that all the macroeconomic factors analyzed have a direct impact on the level of non-performing loans.

Abstract

Local natural resources play an important role in securing human health in the Albania, particularly as a source of medicine. An ethnobotanical field study focused on traditional uses of medicinal plants was conducted in the Kolonja Municipality in the southeastern region of Albania. The aim of the study was to document traditional environmental knowledge concerning the use of medicinal plants. The field study was conducted from September 2024 to June 2025. The methodology employed involved semi-structured interviews and

observation. The names of the local plants, their utilized parts and preparation methods were investigated and recorded. The plant species were collected within the scope of the study and herbarium materials were prepared. Data obtained confirmed the richness of the bio-cultural heritage and showed that in the studied area the folk use of plants is alive and still derives from daily practice.

OPTIMIZING INDUSTRIAL MALEIC ANHYDRIDE SYNTHESIS FOR ENVIRONMENTAL SUSTAINABILITY

Abstract

This study focuses on minimizing the environmental impact of maleic anhydride synthesis by reducing the formation and emission of by-products generated during the partial oxidation of n-butane in an industrial fixed-bed reactor **using industrial data**. Numerical simulations were conducted using a validated mathematical model to analyze the influence of inlet temperature and pressure on the generation of CO, CO₂, and acrylic acid. The results show that increasing the inlet temperature from 325.6 °C to 488.4 °C leads to a slight decrease, with CO₂ molar flow reducing by 0.18%, CO by 0.15%, and acrylic acid by 0.23%. Conversely, increasing the pressure from 1.304 bar to 1.956 bar results in a significant rise, with CO₂ molar flow increasing by 1.32%, CO by 1.19%, and acrylic acid by 2.22%. These findings indicate that higher pressure promotes oxidation side reactions, while elevated temperature slightly suppresses by-product formation. The presented approach provides a valuable foundation for improving reactor design and operational control in large-scale production systems. The application of process optimization based on these insights can enhance yield efficiency and reduce environmental emissions, contributing to a more sustainable industrial operation.

ARTIFICIAL INTELLIGENCE AND SCHOOL LEADERSHIP: EVIDENCE, CHALLENGES, AND IMPLICATIONS FOR THE ALBANIAN CONTEXT

Abstract

The model of Education 4.0 is increasingly emerging from developed countries as a labourmarket demand and is now appearing on the agendas of schools in developing contexts. Every societal transformation is also lived within the school, highlighting the critical role of the school leader. The integration of Artificial Intelligence (AI) into education is transforming school leadership worldwide. Although AI has the potential to enhance decision-making, administrative efficiency, and pedagogical leadership, in Albania there is very limited, almost no research on how school leaders actually use AI in their daily professional practice. This qualitative study, based on in-depth interviews and a three-step thematic content analysis, aims to provide a clear understanding of school leaders' practices and perceptions regarding AI integration. Interviews were conducted with 25 school leaders from pre-university schools across Korça and its surrounding areas. Findings indicate that AI supports data-informed decision-making, resource management, and creativity in teaching methods and ideas; however, significant challenges remain, including limited digital infrastructure, insufficient AIrelated competencies, ethical concerns, and the absence of national guidelines. The study concludes with recommendations for capacity-building, infrastructural investment, and the development of ethical and policy frameworks to support the responsible and context-sensitive adoption of AI in Albanian school leadership.

This conceptual paper emphasizes the importance of Albanian Folk Tales as a rich narrative resource for fostering critical and creative thinking. The aim is to provide a detailed theoretical and methodological framework for the functional integration of folk tales into STEAM (Science, Technology, Engineering, Arts, Mathematic) projects at the primary education level.
